New Business

- 2022 Meeting Schedule Locations are TBD for the September and November meetings. Possibility that Fayette has 1-2 farms that would be available for a field day. They are a stripmine crop system with grazing as option. Preference for the 1st two weeks of May.
 - May or June Field Day (Host needed)
 - Thursday, September 15th
 - Thursday, November 10th
- 2022 Budget
 - Budget was proposed in November and we need to approve it. Rich motions to approve budget, Pierce 2nd, motion carries.
- Changes to Bylaws (Please see attached)
 - 3 points were added under the meetings section to allow for remote meeting. (Rich read aloud the proposed changes)
 - Discussion related to the proposed changes indicated that 10 days is too great of time and should be reduced to 5 days. If there is a REAL emergency, the

executive committee can make a meeting decision (whether or not to have a meeting)

- Next steps are to have the executive committee make a vote on the proposed changes and have a final vote with the whole group at the May meeting.
- Question raised about how to garner greater participation in meetings and perhaps even public participation.
 - Could we do a FB live of the meetings?
 - Could we have a conference call line?
 - Some concerns were raised by agencies regarding live streaming. Registration might be required from a capacity standpoint.
 - Having an educational outreach component of the meetings is a good idea, but technological capacity of the meeting spaces is another concern.
- Bylaws will be sent out for comment between now and May.
- Grassland Evaluation Contest
 - Contest Date proposed for September 29th (Jess motions to hold the contest on the 29th at Ag Progress Fields at PSU, Pierce 2nd, motion carries)
 - Fundraising letters were sent. Need help so if oyu you have an idea for a place to send fundraising letters let us know. We have available letter templates.
 - We need \$5,500 and we are typically not reaching our goal and the organization needs to cover the deficit.
 - PACD does Grassland Evaluation qualify for mini grants? PACD will help us with this contest.
 - Letters drafted to request \$200 per Conservation District
 - We have to do more individual outreach per district so perhaps we can make it annual "donation"
 - SWPG is a 501(c)(3) so donations to the contest can count towards tax write offs.
 - Jess suggests that we task membership with producing 3-5 sponsors
 - We can also plug this scholarship opportunity with Envirothon groups.
 - This is one scholarship that you're not limited on how many times you can win.
 - Add a "donation" button to our website for people to donate online.
 - PA GLC sent \$1,000 for the contest to be used for scholarship but not for contest expenses.
 - T-shirt discussion. Shannon was looking into it. SWPG could vocer ??? the cost and we could get additional advertising and incentives for sponsors?
 - A few prices but there is some concerns about costs since we are already not meeting our fundraising goal.
 - We are a frugal organization so this might be something worth spending our money on.
 - Revisit the t-shirt discussion at the May meeting once we have assessed the progress on fundraising.
 - Volunteers we typically need 15 to run the contest. So plan on participating and get your clearances.
- County Field Day
 - Possibility for field day in Fayette sometimes in the first two weeks in May

- Western PA Grazing Conference Committee
 - In Clarion on March 17th (Registration due by March 10th)
 - As a sponsor we have a table and two registrations (need to be filled)
 - Sponsorship rate reduced
 - Rich motions for the difference in the reduce rate to be returned to SWPG by a credit. Rich 2nd, motion carries.
