#### **New Business**

- Grassland Evaluation Contest
  - o Contest date September 29, Ag Progress Days Site
  - o Advertisement flier, sponsors.
    - Debate on whether or not sponsors should be included on the flyer sent to the schools to advertise the contest.
      - Should advertisement sent to the schools be separate to a sponsors flyer?
      - Create a separate flyer for sponsors
        - o Benefit of sending this out before the competition is that other sponsors could see and be inspired to donate.
      - Possible to make a banner to have at the contest for the sponsors.
    - Recommended changes to the brochure
      - Include homeschoolers as eligible participants
      - Remove sponsors from the brochure and change the "sponsors" to Partners
      - Change Cooperating "Agencies" to "Organizations"
      - Include a sentence indicating you must be in 4H or FFA to participate in the National Contest.
  - Study Guide
    - Registration is no longer available in the guide, but is now available online.
    - Needs to be re-typed. Possible intern opportunity for intern/ PT employee in Fayette/Allegheny CDs.
  - o A minimum of 15 volunteers needed to facilitate event
    - We will be generating a list of volunteer positions
    - Make sure if you need your clearances you start the process sooner rather than later because it can be time consuming. Riley has the list of folks who have already obtained clearances and will send out a list.
  - T shirts
    - Shannon (Cambria) has a cost estimate for t-shirts \$5-\$8 per person.

- Offer a good opportunity for advertising (both for sponsors and the contest when we share our press releases with winners)
- We already saved money on our field day and from the conference so there is extra room in the budget for tshirts. It would only need to be added as a line item to our budget.
- Motion for all Grassland Evaluation Contest participants and volunteers (and a few extras) with a maximum dollar value for tshirts being \$800.
   Rich 1<sup>st</sup>, Pierce 2<sup>nd</sup> motion passes.
- O So far we have raised \$4,100 and we are waiting for more donations to come in.
  - Still need \$1,000 more to cover all of our scholarship obligations.
  - Need someone to take over the spreadsheet for scholarship tracking.
  - Is it possible to give out checks at the contest so we are not tracking scholarship winners over several years?
    - Discussion to be continued.
- O Discussion of making SWPG into a non-profit to issues our own checks for the grassland competition in order to give checks at the event and reduce the long-term record keeping.
  - Discussed once before, however complicated because there are now two tiers of non-profits (separated by income). We would be classified in the lower tier, which would not be subject to audits. However this could make some organizations less likely to donate.
  - Possible item for future discussion.
  - Might be able to have Penns Corner pre-write checks that we could give to teams.
